




# Spending more on treatment, but not getting healthier

CY2021 National Health Expenditures




2021 Total: \$4.3 trillion

#### CDC Program Funding, Adjusted for Inflation, FY 2014–2023








### Preparedness Funding to States Still Inadequate


Public Health Emergency Preparedness and Hospital Preparedness Funding




### **Boom and Bust Cycle of Public Health**





